ELECTRICAL SERVICE CONTRACT

TERMS AND CONDITIONS

IMPORTANT

- a. 24-hour power & dedicated circuits will be double the listed price.
*Use * to indicate 24-Hour Outlet(s).*
- b. Electricity will be turned on within 30 minutes of show daily.
- c. To receive the incentive rate, we must receive your order, along with payment in full or credit card authorization, on or before deadline date. All other orders will be charged at the base rate.
- d. No credits will be issued on unused outlets or lights installed as ordered.
- e. Exhibitors found using outlets without an order will be charged the base rate for outlets used.

HI-TECH ELECTRIC JURISDICTION

(Requires Hi-Tech Electric labor and/or materials)

- a. Only HTE equipment is allowed for electrical distribution. Exhibitors are not permitted to bring their own electrical distribution system.
- b. HTE installs all motor and equipment hook-ups requiring hard wiring connections.
- c. HTE performs all installations and/or repair of electrical fixtures.
- d. HTE performs installation of all electrical motors and electrical apparatus to be energized
- e. HTE electrical labor is required to inspect pre-wired equipment that connects to HTE distribution systems.
- f. HTE provides labor for all overhead truss rigging and overhead booth lighting.

RIGGING LABOR

- a. \$ 80.00 per hour Straight Time 8am-4:30pm M-F
- b. \$152.00 per hour Premium Time After 4:30pm M-F

ELECTRICAL LABOR: OUTLET DISTRIBUTION

- a. Labor rates: \$80.00 Straight time 8-4:30pm M-F
- b. Labor rates: \$152.00 Premium Time
Premium Time applies after 4:30pm, M-F /weekends and holidays.
- c. Lift Rates: \$138.00 per hour (one hour minimum) plus operator's time.
- d. Starting time can only be guaranteed when labor is requested for the start of the working day at 8 a.m. The minimum charge per booth is one hour for installation and half the total time for dismantle. Time will commence per Exhibitor's request. Failure to start labor at requested time will result in one hour charge per electrician requested, unless 24- hour advance notice is provided in writing.

OUTLET LOCATION & DISTRIBUTION

- a. All electrical outlets will be installed on the floor at the draped back wall of in-line and peninsula booths.
- b. All electrical outlets for island booths will be dropped to one main location per the exhibitor's floor plan.
- c. If no plan is provided, the outlets will be installed at our discretion.
- d. Any additional power drops or locations are chargeable on a time and material basis.
- e. Distribution and connection of outlets are chargeable on a time and material basis.

RIGGING JURISDICTION

- a. All exhibit hall rigging must provide a floor plan for approval by Hi-Tech.
- b. All labor for rigging-to-building structures will be provided by Hi-Tech.
- c. No other contractors may attach motorized equipment for rigging to building
- d. Rigging includes all motorized rigging-to-building structures.
- e. Invoices are available on site at the Hi-Tech Electric. All charges for rigging structure.
